SUPERVISOR COMMENTS

Fairly quiet Sunday on dayshift allowing officers to follow up on previous cases and complete reports. A female was contacted downtown this morning screaming and running around. SUPERVISOR COMMENTS

The beginning of the shift was slow. There were three calls to note. The first one was of a domestic violence adult victim. As the victim was talking with a male outside her apartment her ex-boyfriend showed up. The victim's ex-boyfriend accused the victim of her having some of his personal property. The victim denied it and the ex-boyfriend pushed the victim two times up against the exterior wall. The victim's cell phone was stolen by force, and was

hit with a metal object on her head causing a small bump. The victim also had a bruise on her jaw line. The ex-boyfriend left the area prior to police's arrival. An information and belief was filled out for the ex-boyfriend's arrest. The second call was of a strong arm robbery at a local market in the 1500 block of East Ave. The unknown suspect was dressed in all black. He also wore a black ski mask and black gloves. As the call was being dispatched an officer was in the area. An adult male wearing a black beanie was driving out of the parking lot. A high risk stop was done on the driver and he was only person in the vehicle. After a further investigation was done, it was determined the male was not involved and he was released. The suspect entered the market and jumped over the counter and stole an unknown amount of money from the cash register. The suspect then left the area in an unknown direction. The incident was captured on video. The third was on an ongoing investigation involving a juvenile using a stun gun on a victim. The juvenile was I.D.'d from a video surveillance by an officer. The juvenile was contacted at his residence and admitted to using the stun gun on the victim. The juvenile was arrested and booked at juvenile hall. SUPERVISOR COMMENTS
