officer's investigation, the driver was arrested for driving under the influence of alcohol. An on-scene breath test showed a blood alcohol content of over 4 times the legal limit. The driver was booked into jail.

**SUPERVISOR COMMENTS**

Officers were very busy during the night with a mix of calls for service and self-initiated activity. One call, officers investigated a domestic violence battery where the husband was arrested for strangling his wife for over a minute. Officers responded to a panic alarm and contacted a male during their investigation. The male had a felony warrant and was booked into jail. Officers responded to an assault & battery occurring at a downtown bar. When they located the male suspect, he ran from officers. After a short chase he was taken to the ground and a taser was used to subdue the suspect in handcuffs. He was booked for resisting and public intoxication. An officer stopped to investigate a vehicle that was stopped partially blocking the roadway. The driver was passed out behind the wheel, along with the two occupants in the vehicle. The driver was arrested for DWI, and the occupants were arrested for public intoxication. One of the occupants also had a felony warrant; They were taken to jail.
