1. CONDITIONAL USE PERMIT NO. 2016-04 – TURLOCK CROSSROADS MASTER PLAN PROGRAM (Stanislaus County APNs 087-028-006, 087-028-009, 087-028-

**010**, **087-028-011**, **087-028-012**): To authorize a master sign program for the Turlock Crossroads commercial/retail development. The master sign program includes tenant wall signs, pad tenant monument signs, and one (1) 85-foot tall multi-tenant freeway oriented pylon sign.

<u>View Item</u>

- a) Planning Commission determination that Conditional Use Permit No. 2016-04 (Turlock Crossroads) is exempt from CEQA pursuant to Section 15311(a) Accessory Structures of the CEQA Guidelines and action on Conditional Use Permit No. 2016-04.
- 2. MDP 2016-03 TURLOCK CHRISTIAN ELEMENTARY SCHOOL 2323 COLORADO AVENUE (Stanislaus County APN 072-033-003): The applicant is proposing to convert an existing approximately 35,156 square foot professional office complex, including 3,850 square feet of residential and 1,000 of storage area, to an elementary school for approximately 200 kindergarten through sixth grade students. A new approximately 18,800 square foot playground consisting of paving and/or asphalt is to be installed on the south side of the building along Colorado Avenue. The student play areas and campus will be fully enclosed by a wrought-iron style fence.

The facility will generally operate between 6:00 a.m. and 6:00 p.m., Monday through Friday, with classes held from 8:30 a.m. to 5:00 p.m. Occasional weekend and afterhour weekday events and activities will occur on-site. The facility will have approximately 30 employees on site that will park in a parking lot behind the main building.

All students will be dropped off in the parking lot area behind the main building. This area can be accessed from Colorado Avenue on the south side of the building and play area, and Tuolumne Road on the west side of the building, via existing driveways. The following traffic study prepared by the applicant at the current elementary campus. A total of 98 cars were involved in the study:

The school hours are proposed to start at 8:30 a.m. to avoid the 7:45 to 8:00 a.m. peak drop-off times for Dutcher Middle School located to the south on Colorado. The school will run a double lane drop-off and pick-up procedure, which would allow the loading and unloading of 10 to 15 cars at one time.
